6. CONTRACT ADMINISTRATION SERVICES

Allison Rich Services and Resources Ltd maintain a fully staffed construction management department which is responsible for all contract administration, bidding, award of contractors, and in-field construction observation and inspection.

a) Plans and Specifications

All the firm's construction drawings and bid documents are produced in-house by our own engineers and technical support personnel. We provide complete follow through from production of these design documents to bidding. Plans and specifications are distributed through the Construction Management Department, which ensures that all Contractors bidding on the work receive complete and correct set both documents and any addenda issued after their release.





b) Bid Document

Independent internal reviews of the bid documents for each project are performed by our Quantity Surveyor not assigned to the projects we design, and make recommendations to the Owner on selection for a contractor to perform the work. These recommendations are based on a number of factors, which includes the contractor's past performance and the total amount of the bid.

c) Pre-Bid and Pre-Construction Conferences

Allison Rich Services and Resources Ltd organizes and attends all pre-bid and pre-construction conferences in connection with the projects we provide. We ensure that engineers in charge of the project are available to answer any questions potential bidders and contractors. Our engineers have also attended public meeting with our clients to answer question about projects from the general public.

7. Construction Management Services

a) Construction Inspection

Allison Rich Services and Resources Ltd Construction Division maintains daily contact with the project through experienced field inspectors assigned to each job. This daily contact helps keep projects on schedule. It also enables minor changes to be approved on-site, without delays occurring in the schedule. Each construction inspector reports daily to the project manager/project engineer on the progress of the construction. In turn, the project manager/project engineer, who serves as a point of contact for both the client and the contractor, ensures that the principal in charge of the project is kept informed. The construction management procedures outlined above are standard practices for all jobs undertaken by Allison Rich Services and Resources Ltd. We are accustomed to performing these services on a daily basis.





b) Final Inspection

8. Quality Assurance/Quality Control
